

Procedure

The BA Controllable Reduced Pressure Zone backflow preventer is subject to mandatory annual maintenance. A BA backflow preventer maintenance sheet is provided with the test case.

This "maintenance sheet" must be completed by a qualified technician.

To prevent any deterioration of the pressure gauges, open the valves slowly.

Application

The Test Kit for backflow preventer allows the control of a wide range of sanitary protection sets type BA ranging from DN 6 up to DN 250. Materials in contact with potable water are food grade and stainless.

This case is equipped with quick couplings for easy connection and easy use.

The glycerine included in the upstream and downstream manometers protect the device from any water hammer and allows a progressive reading of the values.

A zone for reading range of the differential pressure gauge from 0 to 0.14 bar is identified by the red color.


The hoses have excellent flexibility and can be rolled up in the case.
